An individual skill development program was held nine times between April and December. This program targeted private citizens in the community. The 47 people who participated in the program took initiative to think and act for their community.

Projects to train and foster personnel who have a global perspective and to enable children to take the first step toward world peace. We did a project relating to UN MDGs (United Nations Millennium Development Goals) for the children in the community. The project relating to UN MDGs was carried out at three elementary schools and two junior high schools in Yamagata City. 350 children in the community participated.

Members of JCI Yamagata conveyed the worthiness of JCI activities as well as their confidence and pride to the people in the community. As a result, membership expanded.

In order to turn young people considering membership into active citizens, eight introductory seminars on JCI activities were held in the course of a year.

As a result, JCI Yamagata further enhanced the global network of JCI.

<2. Work together with more private citizens and corporations to positively change the people of the local community and impact the local economy.>

Held a reception for the governor of Yamagata Prefecture, mayor of Yamagata City and representatives of 16 of the most influential corporations in Yamagata in order to raise their awareness of ASPAC and JCI activities. The number of non-JCI members in attendance was 103. We introduced the attendees to the activities of JCI and the programs to be held at the ASPAC. The attendees profoundly understood our presentation and positively changed. They offered their complete cooperation for ASPAC.

Planned and ran the Yamagata Fireworks Festival, which was held on August 14, 2013. We collected USD350,000 in sponsorship. 270,000 people of the community came to the Yamagata Fireworks Festival, which was produced using the sponsorship money. Companies retuned the profits to the community and fulfilled their social responsibility. The 270,000 citizens benefited from the companies' social responsibility.

JCI Yamagata conducted an individual skill development program for private citizens in the community. The 47 people who participated in the program were positively changed after the completion of the program. They took initiative to identify issues in the community, and conceived and executed projects. These citizens, who were impacted by the program and became active citizens, are currently involved in the following projects.

- A project to deepen the understanding of community in Yamagata, and to train and foster personnel. < LI > A project, in cooperation with the Board of Education, for 100 high school student-leaders to discuss future careers with adults in various jobs.

Carried out a project relating to UN MDGs (United Nations Millennium Development Goals) for the children in the community.

We carried out a project at three elementary schools and two junior high schools in Yamagata City to learn about UN MDGs and create solutions. 350 children in the community participated.

Recommendations: THE BROTHERHOOD OF MAN TRANSCENDS THE SOVEREIGNTY OF NATIONS.

We believe it is very effective to undertake various activities together with sister JCs.

Even in far away places, our activities influence local chapters through our sister JCs. We found that the project spreads widely, transcending country and region. However, spreading the impact of a project requires work to maintain relationships with sister JCs.

Our Tohoku partners and we have been given the opportunity—JCI ASPAC Yamagata—to show various people from all countries and regions that we are positively changing.

From the above, we believe Objectives 1 and 5 were greatly achieved.

THE ECONOMIC JUSTICE.

We created a project model wherein a company can fulfill its social responsibility, and all people, regardless of economic status, age or sex, can benefit from the company's social responsibility. This project model has been maintained for 34 years and has become a significant regional development project.

EARTH'S GREAT TREASURE LIES IN HUMAN PERSONALITY.

The following was considered important based on the various projects we carried out for the people in the community.

When a program starts:

- 1. Convey to the participants the attractiveness of the program we offer
- 2. Participants sense that they will be changed after the program is finished.

During the program and at the end:

1. Participants want to create their own story/future beyond the program.

Of the projects we carried out, all three of these aspects were successfully realized in the individual skill development program. For the UNMDGs project, aspect No. 3 needs to be strengthened. We think improvement will come from: demonstrating that society is impacted when many people do small things, individually; and presenting specific actions to that end.

JCI Yamagata considered the following points to bring positive change in the community.

- 1. Connection of JCI Yamagata and sister JCs.
- 2. Connection of JCI Yamagata and the people in the community.
- 3. Connecting the people of the community to the world.
- 4. Connection of JCI Yamagata and JC members in the Tohoku District.
- 5. Leadership training of JCI Yamagata members.

JCI Yamagata carried out projects that will impact itself as well as the people around it in order to change the community.

Every member took on enhancement responsibilities and participated in member expansion activities. As a result, ties to young business people of the community were broadened and 39 new members (33%) were added. Additionally, activities were widely communicated to the general population as each member deepened their understanding and spread awareness of JC activities. We called this the POWER UP 40 PROGRAM.

JCI Yamagata performed activities to implement ASPAC together with sister JCs for the purpose of causing positive change in the community. ECONOMIC JUSTICE CAN BEST BE WON BY FREEMEN THROUGH FREE ENTERPRISE!! >

For 34 years, JCI Yamagata has been organizing projects in which private citizens of the community, regardless of economic status, age or sex, benefit from corporate social responsibility.

Every year, we have organized the Yamagata Fireworks Festival with the cooperation of Yamagata City and the community.

We create a theme for the project every year. The theme concerns positive change in people. The project is planned and run according to the theme.

Corporations return a benefit to the community by providing sponsorship money to the project, which provides the opportunity for private citizens to think about sustainable development of their community.

JCI Yamagata created a way for corporations to fulfill their social responsibility to the people in the community.

- 1. All kinds of corporations in the community offer money for the community.
- 2. We use that money to plan and run projects.
- 3. Private citizens of the community, regardless of economic status, age or sex, are benefited by our projects.

We raised USD350,000 in sponsorship money from over 1200 companies in the community for the 2014 Yamagata Fireworks Festival. In 2013, 270,000 people who came to the Fireworks benefited from the social responsibility of corporations.

Many corporations continue to impact private citizens in the community through the schemes we have

created over the past 34 years.
